Policy Regarding Aggressive Dogs

The Club's Training instructors have many years' experience in training dog obedience and have the requisite skills to address most dog behaviors. However, our instructors do not have specialized training to address aggression in dogs. The Club therefore has the following policy which we ask you to please read carefully.

NOSA Instructors will watch for aggressive dogs during class time. Any dog exhibiting aggression in the form of attacking or biting another dog or person, or a dog that is considered to pose a threat to other dogs or people, may be required to leave the class at the Instructor's discretion. Instructors will bring all aggressive tendencies to the attention of the Training Chair, who may, after observation, require that the dog cease training with NOSA. The Training Chair will provide the handler a clear explanation for this action, including the detrimental effect on other dogs in the class, risk of injury to dogs or people and possible liability for our club. If available, a referral to a specialized training school offering remedial behavior classes will be made. A reimbursement of class fees may also be offered depending upon the circumstance.
